



STATE PREVENTION SYSTEM

Structure and Organization

The lead ATOD agency in Alaska is the Division of Alcoholism and Drug Abuse (ADA) of the Department of Health and Social Services (DHSS). A commissioner, assisted by two deputy commissioners, administers DHSS. The Divisions within DHHS include:


- Division of Alcoholism and Drug Abuse
- Division of Administrative Services
- Division of Family and Youth Services
- Division of Medical Assistance
- Division of Mental Health and Developmental Disabilities
- Division of Public Assistance
- Division of Public Health

ADA has three offices, two in Anchorage and one in Juneau. The major functions of the Juneau office include policy and program development, administration, and grants management. One office in Anchorage houses the ADA field staff responsible for technical assistance, treatment program approval, and quality assurance. The second Anchorage office is the Alcohol Safety Action Program, which provides assessment, referral, and monitoring of court-referred alcohol related misdemeanor offenders.

In July 1998, the State of Alaska was awarded a State Incentive Grant from the Center for Substance Abuse Prevention (CSAP). The project director and staff for this prevention effort are located in Juneau. The Governor has appointed a twenty-four person Prevention Advisory Council to provide policy guidance to the project.

Prior to the award of the State Incentive Grant, the 20 percent set-aside for prevention in the Federal Block Grant, was awarded in its entirety to the Alaska Council on the Prevention of Alcoholism and Drug Abuse, a non-profit organization based in Anchorage. The Council provides public information, the State RADAR network center, an extensive resource library, a quarterly newsletter The Prevention Express, and sponsors a three-day Prevention Symposium. The Symposium is the annual prevention training conference held in the State.

PROGRAMS AND SERVICES

Definition of Prevention:

Alaska defines prevention as "the dissemination of relevant information in a regular and planned way that presents a philosophy that increases awareness and receptivity of the community to the nature of the use and abuse of alcohol and other drugs, treatment, and prevention issues. Education also presents the human and legal rights of the population at risk, as well as informing the public of existing resources and stimulating social action to increase support for the development of additional alcohol and other drug resources."

Does the State have prevention plan?

Yes, it is part of the overall State Plan for Prevention and Treatment Services.

DATA COLLECTION ACTIVITIES

Results currently available on prevention programs funded by the 20% set-aside (including needs assessments and data collection):

Data on current prevention activities and available resources are contained in State grantee reports. The Field Operations Unit (Anchorage) conducts annual on-site reviews of all Statefunded programs and of programs seeking State approval. All aspects of operations and services are reviewed. The information is used to establish compliance and approval status and to determine technical assistance needs.

Alaska prevention planners have access to data from various State departments and agencies, and from program reports. The State presently collects data, in diskette form, for each of the six CSAP strategy areas. However, Alaska requires financial assistance at the State and substate levels to institute a formal and uniform proactive community-based needs assessment process to help in local and statewide planning.

The State has an initiative to develop empirically-based outcome measures that can be appropriately applied to measure the short- and long-term effects of substance abuse treatment and prevention services funded in Alaska. Also, the plan is to establish baseline performance levels for all prevention and treatment programs funded by ADA using defined outcome measures and realistic performance standards and goals.

SUPPORT SERVICES

Training and Technical Assistance:

The State provides training grants for prevention staff in its three substate regions (Anchorage, Fairbanks, Juneau). No SAPT Block Grant funds are used for these training activities.

Certification Activities:

The State of Alaska does not have a certification process for substance abuse prevention professionals.
